hereby waive any right to inspect or approve the finished videotape, sound track, photograph, advertising copy, audio piece, or printed matter that may be used or to the eventual use that it might be applied. We hereby waive any and all rights to compensation from the duplication, broadcast and advertising of the product.

We hereby release, discharge and agree to hold harmless the Sacramento All, Sketch Comedy Festival organization and its producer and all associates from and against any liability as a result of any use, distortion, blurring or alteration that may occur or be introduced in any use or broadcast of the material.

In exchange for release, we receive the opportunity to perform and accept that there is no promise of additional payment, in any form for likeness, image, biography, recording, equipment, or for any other contribution by us on this production. We understand that the producer and production company are relying on this full and complete release in proceeding with the production and exploitation of the production. We warrant that the use of the rights granted here and of any material supplied by us will not violate the rights of any third party. We agree to defend, indemnify and hold harmless the Sacramento All Sketch, Comedy Festival organization, its board and employees and associates, from any claims by third parties alleging that our content or material infringes on any third party's rights. This Release and Hold Harmless Agreement shall bind my assigns and any representative.

We hereby release from liability and agree to hold harmless the Sacramento All Sketch Comedy Festival organization and its producer and all associates from and against any liability for any personal injury (to any person), damage or property loss that occurs as a result of our participation in the Festival.

We agree to abide by the rules and regulations of any venue in which we will perform during the course of the Festival and agree to pay for any damage or fines for rule infractions that are attributable to us.

We agree that the legal venue and jurisdiction is Sacramento County, California State, and we agree that any prevailing party in a court of law will be entitled to an award of attorney fees. I hereby certify that I am over eighteen years of age and competent to contract in my own name.
